JC noted that in his opinion the Brum was a mess and needed some work.

- 5.1 Report on the Bunnies on the Brum event. MF noted that the event was all set to go ahead on Saturday 6 April 12 -2pm.
- 5.2 Rospa report had been received and there were 3 areas that needed attention and Top Cut had been notified.
  - Gate for play area was not soft closing and needed attention.
  - The basketball hoop needs some attention at the base.
  - The goal posts are a bit wobbly and need attention.
- 5.3 The lease for the Brum recreation ground was received and will be signed at the next meeting.

  - It was agreed that a meeting with relevant people from Highways (Kieron Hemstock, Gerry Brienzas replacement, Adrian Tuck etc.) and the parish council should be set up by A Miller. A Miller was awaiting a date from AMM.

  - AM noted that the new traffic lights at Hurst Road/A38 were to be scheduled for the summer holiday. Street works will be coordinating to ensure that notices will be given to residents and that a final meeting was still awaited.
  - Dilmore lane widening issue still with the legal team but was in the final 28 day phase. The land in question has had ownership resolved. If no satisfactory agreement is reached, then enforcement action will go ahead and the developer will widen the road.
  - Light 005 Western Power are to visit and rectify supply and lantern.
  - A38 from the SPAR to Agatha Gardens the road is in a poor condition after the recent works.
  - WCC log 678422 asked for the removal of a stanchion that was surplus to requirements.

#### 12 Purchase of land

The Parish Council has received new information on two plots of land available to buy in the parish and an outdoor feasibility study into the purchase of land for the community has been undertaken on behalf of the Parish Council by Peter Hamilton Planning.

The Parish Council has been advised to proceed with the purchase of the land (to be known as Sandy Way) off the A38. The Council voted to proceed with this action. The solicitors MFG in Worcester have been contracted by the Parish Council to proceed with the purchase of land on behalf of the Parish Council. Wychavon have approved the use of s106 monies for the purchase of the land and the Clerk is in the process of ensuring the funds are available for this purpose and has transferred the monies held at WCC to the Parish Council main bank account for easy access. Further details will be discussed at the meeting of the Finance Committee in May 2019.

#### 13 Parish Maintenance

This is an opportunity for Councillors to raise matters re parish maintenance. Litter-picking dates are to be arranged.

## 14 Elections

The Council is to be re-elected on 2 May 2019. Any Councillors or members of the public who wish to join the Parish Council must return nomination forms by 4pm on Wednesday 3 April 2019. #### **Public Question Time**

<u>S Routledge</u> asked NCPC if there had been any action re the **speed limit in Bevere**. Cty Cllr A Miller noted that Barrie Barnes at WCC had been tasked with looking at the safety of the road in question and will provide a report at the next Parish Council meeting. AM also noted that he would look into a flashing "Slow down" sign for Bevere Green.

<u>S Routledge</u> also noted that the **dog waste bin in Bevere** was full. The Clerk noted that WCC operated on a "when a bin is full – it will be emptied" premise and she had reported the bin as full. It is anticipated that the bin will be checked more often by the contractors and thus emptied more frequently – but to ensure this happens, the Clerk suggested locals report the bin as needing emptying via the WCC site as soon as possible.

<u>T Foxall</u> noted that the **public open space** (POS) in **Cherry Tree Park** was paid for by residents. It was noted that the residents felt this was unfair and would like Wychavon to adopt the POS.

County Cllr Miller noted that the management company (set up by Bellway) who looked after this POS were not willing to relinquish the management of the space.

The Parish Council agreed that they would discuss this matter at their next meeting under the following agenda item "Do the Parish Council wish to send a letter supporting the residents' concerns with regard to the ownership/management of the Cherry Tree Park open space, to Wychavon DC?"
