- 4.1 Progress reports and matters arising.
 - Agatha Gardens bed needing attention. MF and MD to action this in the Autumn after the Summer flowering season has finished.
 - Overgrown shrubbery at 224 Droitwich Road obscuring a triangular sign.
 - Accident on Epsom Close due to car crashing into fence on corner.
 MF is to discuss this situation with Richard Rees at the next PACT meeting and MB is to investigate this also.
 - Clerk to investigate the whereabouts of the moveable VAS.
 - School Bank. Ongoing

The Parish Council agreed to all the 6 suggestions from Barry Barnes after the meeting at the School in September 2021. Cllr Marc Baylis is to ask for these items to be put in places soon as possible.

The dropped curb and payement that provides access to Philips' Farm.

The dropped curb and pavement that provides access to Philips' Farm was repaired in November/December 2021. the pavement is again very cracked and damaged –higher quality alternative be used at this location. To be actioned by M Baylis

5 Public areas in North Claines Parish.

5.1 Recreation Committee report their progress.

Bull Meadow

The Parish Council agreed that Paul Miller at Fairways would source a gate for the entrance of Bull Meadow.

A management plan for the future of Bull meadow is to be drawn up. All planning permissions are now in place and Andrew Fell from WCC drainage has confirmed that ordinary watercourse land drainage consent work is not necessary as the work is over 10m away from the Martin Brook. This work is to be completed by April 23 to obtain the funding from the Worcestershire Wildlife Trust (WWT). The work will be checked by Becca Brant from the WWT. Project documents are to be kept for 10 years and their logo is to be used on publicity and information boards.

<u>Brum</u> The Parish Council agreed that new football posts at £866.94 plus an extra sleeve would also be purchased.

Surface under the agility trail needs attention.

- 5.2 Community Café for North Claines Parish. After the success of the two weeks in the summer, the pop-up café is to go ahead over the half term and scarecrow week. A marquee has been donated for use on the Brum. It was noted that for a permanent café to be investigated then a business plan was needed.
- 5.3 Scarecrows in Fernhill Heath. There are 100 going up in the Parish and Hereford and Worcester Radio are promoting the event over half term.
- 5.4 Opportunity for Councillors to raise matters regarding other open areas in the Parish.

Items for Top Cut to action.

- Filling in on holes on the play area surfacing
- No parking sign to go up in Agatha Gardens
- Top cut to use the mastic to fill cracks of the wet-pour.

- To clear the side of Bungalows (to the right from road) of ivy and saplings etc.
- Conifers on Agatha Gardens to be cut back to about 6ft.
- Bramble area on Agatha Gardens by the Electricity box needs clearing and tree to be planted.
