Bull Meadow

Pedestrian entrance – fencing is ongoing, and the works performed by Fairway are proceeding well. The pedestrian entrance is proceeding at the present time and the ponds have been paused until drier weather. It was agreed to accept the quote from Top Cut for the planting of 1700 trees on Bull Meadow and this would go ahead early in 2023.

Brum

Nothing to report.

The Pop Up Café is scheduled for the 19th December in the Memorial Hall.

6 Highways, Footpaths and Lighting.

- 6.1 Opportunity to discuss any matters arising from correspondence. Nothing to report.
- 6.2 Update on lighting problems in the Parish.

 The ongoing problems with light number 25 are due to end with a new column to be installed by Prysmian at this location before the end of the year.
- 6.3 Dilmore lane missing footpath by Danes Green.

A parishioner had to go in the turf/mud to get round a flood and slipped and fell in the road.

The Parish Council noted that this lack of footpath needs addressing as a matter of urgency. This is in the remit of Taylor Wimpy (TW) and AM noted that this should be completed by Summer 2023. This is an ongoing problem that has not been resolved since the original construction of the Shire Housing Development. NCPC note that this should be addressed as a matter of urgency. John Hobbs and Adrian Tuck from WDC escalated the issue and AM to pass these details to the Clerk.

6.4 Other highways information or problems.

Notice of the closure of Morton Avenue, North Claines, for carriageway patching. This provision shall continue in force for a maximum of 5 days, however, it is anticipated that it will remain in force for 1 day from 30 November.

It was noted that there were no surprises in this publication. The SWDP includes a parcel of land that backs onto Danes Green and Dilmore for 40 dwellings.

There are also parcels of land either side of Station Road and a parcel of land around Kennels Lane.

9.1 Report from M Bayliss

MB noted that he was having the bridge at School Bank examined and JR noted that as the traffic became heavier this issue was becoming more urgent.

MB noted that he would investigate the progress of actions at School Bank by B Barnes further to the meeting at the School in 2021.

9.2 Report from N Wright/A Miller

The budget for WCC is to increase by around 5% due to an £8.5million deficit -73% of the budget is spent on care for the old and the young in the County.

The County boundary review is to be reviewed in 2023.

Wychavon is not putting their tax up.
