These minutes were approved as correct and signed accordingly.

4 Progress reports from the previous minutes and any matters arising for information (if not considered elsewhere on the agenda)

- 4.1 Progress reports and matters arising.
 - The council agreed to ask Cty Cllr MB to investigate a possible reduction in the speed limit outside the entrance to the Bull Meadow, the Council noted that they thought that if the 30MPH sign could be extended to after the entrance then it would keep users of the area safer. MB agreed to follow this up.
 - MB also agreed to pay for the accessibility access onto the Brum Recreation Ground.

 The VAS on the A38 was up and it was noted that this can be moved around the Parish as the Council wished, although an additional pole will need to be approved and installed in Dilmore/Station Road.
 AH/JR and MT noted that they would be happy to meet MB and Barry Barnes to this effect.

5 Public areas in North Claines Parish.

5.1 Recreation Committee reported progress as follows.

Bull Meadow-

Update from the committee.

- 4 Benches are to be installed on the Brum Recreation Ground.
- Work on access at Bull Meadow by Fairways £8750 quote had been received. It was agreed to accept this quote as Fairways had worked with the Parish Council on Bull Meadow and it was felt that they knew the work required to finish the project.
- 5.2 Opportunity for Councillors to raise matters regarding other open areas in the Parish.
 - Football posts had been removed to deter an adult football team.
 They are not full sized goals and are for casual use and not organised team use.
 - It was agreed to re-install the Football posts on the Brum for use by younger players. MB is to chase up the availability of a PCSO to monitor the situation.
 - 2 benches are to be installed in Agatha Gardens and opposite the school by Post Office Lane.
- 5.3 Scarecrow event and pop-up café update.
 - The scarecrow event was a great success. Visitors came from far and wide to see all the scarecrows and the pop-up café was very busy and made a profit of £1600 which will pay for 2 more benches in the Parish.
 - The Chairman of Wychavon would come to the next Parish Council meeting to award prizes for the best entrants. The winners were.
 - 1 = Strictly Come Dancing.
 - 2 =The Cub Scouts
 - 3 = Marshmallow Man.

Individual prizes are to be awarded to.

- 1 =The witch on the lamppost.
- 2 = Ironing Board Man
- 3 = ET

And the "Chairmans Choice" was Hindlip School.

- 5.4 New bins as requested.
 - One large floor mounted bin on the Brum recreation Ground.
 - One additional dog waste bin on the Brum recreation Ground.
 It was agreed to get the above current bins emptied more regularly.
 - One dog waste bin on Station Road in Fernhill Heath at the bottom of the steps from the bridge over the railway near the lamp post -£175 approved.

- One dog waste bin near the Grange school roundabout £375 approved.
- 5.5 The Bench at Mildenhall Mill needs attention. Cllr VH agreed to investigate this bench and report back to the Parish Council.

 - Dilmore Lane South Bus stop. The surface of this is uneven and results in water accumulating at the back where people sit. MB noted that he would look at this problem with Barry Barnes.
 - There had been a defibrillator issue at the memorial hall when access had not been possible. It was noted that there was no defibrillator elsewhere in Fernhill Heath and the Clerk will investigate funding for one.
 - Danes Green Noticeboard it was agreed that the resident near to this board could make a new board.
 - Complaint from Parishioner re Hurst Lane traffic lights and this was being addressed.
 - To WCC Reported drainage issue Cresswell Close path but it is a private path.
 - To WCC Overgrown trees on Green Lane in Bevere.
