# NORTH CLAINES PARISH COUNCIL (NCPC) MINUTES OF THE MEETING HELD on Monday October 6<sup>th</sup> 2025

- 5.3 The Council approved the minutes and discuss matters arising from the second quarterly finance meeting held on 1<sup>st</sup> October 2025.
  - Bank reconciliation to the end of August 2025 £87,400.18
  - Bank reconciliation to the end of September 2025, £133,569.53
  - The Council approved the recommendation of the Finance Committee that the precept for 2026-27 will be £120,510 which is a 3% increase on 2025-26 (if the tax base remains unchanged)
  - It was noted that the next Finance committee meeting is scheduled for 21 January 2025 – to examine third quarter 2025-26 (October-December incl)

## 6 Public areas in North Claines Parish.

- 6.1 The Brum Recreation ground.
  - To discuss the electricity facilities on the Brum and agree the future maintenance schedule. It was noted that GS Adams had visited the site and that 3 of the 4 lights were now working. A new LED needed to be fitted to the remaining lights. Both electricity boxes need attention, and it was agreed to action this as soon as possible.
  - Update on the play-area surface maintenance. It was noted that PD Hughes had mended the surface. The swings would be re-installed. The Clerk is to source shackles for the swings.
- 6.2 Bull Meadow
  - Progress update re the Memory trees. It was noted that 20 mature trees would be planted on Bull Meadow and Top Cut has quoted £20 per tree to be planted in December (to include a watering hose). The council agreed to this expenditure. The trees would be available for adoption as memory trees from Spring 2026.
  - Information signs. Example received and circulated for consideration.
     The Council approved the example as provided by Cllr AH and quotes for pedestals to be obtained.
- 6.3 Events run by the Parish Council update.
  - It was noted that the scarecrow event was to be held from 27 October to 3 November and the pop-up café would also be open on Westfield Road for the duration. The Council approved the printing of the

information map and any money raised from donations for the map was agreed to be donated to the "Men's Shed" charity.

6.4 Opportunity for Councillors to raise matters\_regarding other open recreation areas in the Parish.

It was noted that there was some anti-social behaviour on the Brum.

- The reorganization of County and District is on-going, and 5 Councils affected have voted for a 2 unitary council approach over the whole area in question. The Government will make the decision in May 2027 and the new approach will take over in April 2028.
